REPRESENTATIONS: The Petitioner is represented by Toun-Ya Legal Consultancy and Arbitration Chambers, and present in Court is Cllr. Kabineh M. Ja'neh. And respectfully submits.

THE COURT: The Petitioner's representation is hereby noted. The Court hereby appoints Cllr. Joseph P. Gibson to receive the ruling on behalf of the Respondents.

To which appointment, Cllr. Joseph P. Gibson accept.

COURT'S FINAL JUDGMENT

The Petitioner in these proceeding instituted the current action to have the Respondents ousted from property which they are acquired from the Township of West Point, rights to reside thereon. The property in question was previously being used pursuant to squatter's rights granted by the Township, by Charles K. Johnson et al.

In 2023, specifically May 8, the Petitioners were given the right to reside on the said property due to the previous occupants having transferred the squatter's rights to Petitioner.

This Court says, the squatter's rights given the Petitioner by the Township of West Point is clearly within the rights of the Township, and the said rights allowed the Petitioner to claim ownership of the said property even though said property is not legally owned by them. This right also allows the Petitioner the rights to take all necessary steps in ensuring the quiet and peaceful enjoyment of the rights granted, and to institute proceeding against any third party who's interfers with such rights of possession.

The Petitioners alleged that the Respondents have illegally and without authorization occupied the property subject of the squatter's rights, and prays this Court to have the said Respondents ousted from the premises.

The records show that the Respondents were duly served and brought under the jurisdiction of this Court. Their failure to file an Answer in these proceedings following the expiration of the ten(10)-day period of the last publication, placed the said Respondents on a Bare Denial of the averments of the Petitioners' Petition.

The Notice of Assignment for the Disposition of Law Issues and for the trial of this case were all served by publication and at the call of the case on the date of the trial, the Respondents were absent from the bailiwick of this Court. At the request of the Petitioners, this Court entered an imperfect judgment of default against the Respondents, and the Petitioner was required consistent with law, to make perfect the Imperfect Judgment. The Petitioner presented two (2) witnesses in persons of Pastor Edwin F. Korpu and Mr. Harrison Jarka. Both witnesses testified that the Petitioner was a legally existing entity and each witness gave testimony as to how the Petitioner came to acquire the said property subject of this dispute, and for which a squatter's rights was granted, a squatter's right Certificate issued by the Township of West Point, and signed by its Commissioner. These were admitted into evidence upon the testimonies of the witnesses.

As already mentioned above, squatter's rights is a claim of ownership to a parcel of land or piece of property, and a squatter has a right to take legal action against any person who interferes with such right. As the property in question is real property, the said squatter's right is a form of title vested in the Petitioners. Section 62.21 of the Civil Procedure Law provides that "where title to real property is not in issue, Summary Proceeding to Recover Possession of Real Property may be maintained in the Circuit Court or a Court of the Justice of the Peace or a Magistrate. Section 62.22 (ibid) further provides that were summary proceeding to Recover Possession of Real Property is granted, the relief may include a Judgment for rent due and for damages for the wrongful withholding of the property.

This Court says, the imperfect judgment entered against the Respondents, and made perfect by the Petitioner based upon the testimonies of the witnesses and the documentary evidence adduced, the Respondents are hereby adjudged LIABLE in Summary Proceeding to Recover Possession of Real Property. Further, because the Respondents are wrongfully withholding the Petitioner's property, the said Respondents are hereby LIABLE in damages for wrongful withholding and shall pay the Petitioner the amount of One Thousand United States Dollars (US\$1,000.00) as damages for the said wrongful withholding the property.

WHEREFORE AND IN VIEW OF THE FOREGOING, the Petitioner's Petition is hereby granted and the Respondents are hereby ordered ousted, ejected and evicted from the property subject of these proceedings and LIABLE in damages for wrongful withholding in the amount of One Thousand United States Dollars (US\$1,000.00). The Clerk of Court is hereby ordered to issue the Wirt of Possession and have same placed in the hands of the Sheriff to have the Respondents ousted, ejected and evicted from the Petitioner's premises. The costs of these proceedings are hereby ruled against the Respondents. And it is hereby so ordered.

EDITORIAI Liberia's dealing with ECOWAS

In less than six months, the Economic Community of West Africa is back in Liberia for mediation amid the current leadership crisis in the House of Representatives at the Capitol Building. Forty-three of the 73 members of the House are opting to oust Speaker Fonati J. Koffa, accusing him of conflict of interest and corruption, charges the Speaker has denied.

On the other hand, 30 lawmakers are standing with the Speaker, though no side has been able to obtain a quorum to conduct business in the main chamber, holding the business of the Liberian people hostage.

About three months ago, ECOWAS was in the country following a bloody standoff between riot officers of the Liberia National Police and partisans and supporters of the former ruling Congress for Democratic Change (CDC) of Ex-president George Weah.

Though the regional bloc denied that its visit then had nothing to do with the fracas that left both police officers and stonethrowing rioters wounded, it came just after former President George Manneh Weah officially complained to the United Nations, African Union, and ECOWAS for alleged witch-hunt of his former officials by the government of President Joseph Nyuma Boakai. Mr. Weah also complained about the government denying him using the VIP Lounge at the Roberts International Airport, which caused his supporters to protest.

Despite the denial, the ECOWAS delegation met with President Boakai and former President Weah separately while in the

This time, the ECOWAS Parliamentary Mediation Mission is visiting Liberia to mediate between the factions in the House.

On November 8, 2024, the Economic Community of West African States sent a formal communication to embattled Speaker Jonathan Fonati Koffa, informing him and his colleagues about [the presence of its Parliamentary Mediation Mission in the country. The mediation, scheduled to take place from November 11 to 15, 2024, aims to address the ongoing political impasse within the 55th Legislature, specifically in the House of **I** Representatives, that has stalled legislative work.

But how does Liberia, a member country, want to work with the regional bloc when, in one instance, the Government of Liberia arrogantly ignored a ruling from the ECOWAS Court and, in another instance, it seeks the body's intervention in its political impasse?

The House of Representatives under the former 54th Legislature impeached Supreme Court of Liberia Justice Kabineh Ja'neh. Ja'neh filed a complaint before the Court and received a ruling in his favor, calling for reparation. However, the Government of Liberia has yet to respond accordingly.

In its ruling, the regional court ordered the Government of Liberia to award Justice Ja'neh US\$200,000 as reparation for moral prejudice suffered in violation of his rights. However, the government has yet to pay.

Now it needs the intervention of the very body to resolve the crippling crisis in the House of Representatives that is stalling public hearings of the National Budget, leading President Boakai to beg the legislature for additional days to submit the budget.

It is important that we, as a country, learn to treat international bodies that we are a part of with respect to sustain such relationships because we will always need them, as in the current case, especially a body to which we have sent two justices to serve. Yet, we have continued to ignore its decisions.

The MoU establishes a strategic partnership between NPA and Marsa Maroc, a leading Moroccan port operator, to modernize and expand key ports in Liberia under a comprehensive Development Master Plan. The signing ceremony which took place at the headquarters of the NPA early today, marks a milestone for both Liberia and Marsa Maroc, with two primary projects aimed at advancing port capabilities:

Development and Operation of a New Multipurpose Terminal at the Port of Monrovia: The partnership will pursue a Public-Private Partnership (PPP) concession to develop a modern multipurpose terminal. This terminal will accommodate a diverse range of cargo, including dry bulk and general cargo, enhancing operational efficiency Monrovia's principal port.


Lighe stresses the importance of collaboration among member states in transforming RMU into a world-class institution. "The sustainability of RMU is not a

Crise politique : La CEDEAO de retour en Libéria

our la deuxième fois en moins de six mois, la Communauté économique des États de l'Afrique de l'Ouest (CEDEAO) est de retour au Liberia pour une mission de médiation. Cette fois, l'organisation intervient dans un contexte de crise de leadership à la Chambre des représentants, où 43 des 73 députés réclament la destitution du président de l'Assemblée, Fonati J. Koffa, l'accusant de conflit d'intérêts et de corruption accusations qu'il dément fermement.

De l'autre côté, 30 parlementaires se rangent derrière le président Koffa, mais aucun des deux camps n'a jusqu'ici réussi à obtenir le quorum requis pour dénouer l'impasse et reprendre les travaux parlementaires, paralysant ainsi les affaires publiques du pays.

La CEDEAO avait déjà déployé une mission au Liberia il y a trois mois, après de violents affrontements entre les forces antiémeutes de la police nationale libérienne et les partisans du Congrès pour le changement démocratique (CDC), ancien parti au pouvoir de l'ex-président George Weah. Bien que la CEDEAO ait nié tout lien entre cette visite et les violences, elle est intervenue peu après que M. Weah eut officiellement saisi les Nations Unies, l'Union africaine et la CEDEAO, accusant le gouvernement du président Joseph Nyuma Boakai de persécuter ses anciens collaborateurs. L'ancien président avait également dénoncé le refus du gouvernement de lui accorder l'accès au salon VIP de l'aéroport international Roberts, déclenchant des manifestations de ses partisans.

Malgré ses démentis, la délégation de la CEDEAO avait rencontré séparément le président Boakai et M. Weah, marquant ainsi un effort pour désamorcer les tensions.

Aujourd'hui, la CEDEAO a envoyé sa mission parlementaire de médiation pour tenter de résoudre le blocage au sein de la Chambre des représentants. Le 8 novembre 2024, la CEDEAO a officiellement notifié au président Koffa et à ses collègues la présence de cette mission au Liberia, avec pour objectif de faciliter un dialogue entre les factions en conflit et d'apaiser l'impasse politique qui paralyse la 55e législature.

Mais une question de fond demeure : comment le Liberia, en tant que membre de la CEDEAO, peut-il à la fois ignorer de façon flagrante une décision de la Cour de la CEDEAO, tout en demandant son intervention pour régler ses crises politiques internes?

Sous la 54e législature, la Chambre des représentants avait voté la destitution du juge de la Cour suprême Kabineh Ja'neh, qui avait ensuite obtenu gain de cause auprès de la Cour de la CEDEAO, cette dernière ordonnant au gouvernement libérien de verser 200 000 USD en réparation pour violation de ses droits. À ce jour, cette décision de justice reste pourtant inappliquée.

Le paradoxe est donc manifeste : alors que le gouvernement libérien sollicite aujourd'hui la CEDEAO pour résoudre la crise interne à la Chambre des représentants qui bloque l'audience publique sur le budget national, il continue de négliger les décisions de la même organisation. Ja'neh has accused Justice Minister Oswald N. Tweh and Police Chief Gregory Coleman of allegedly kidnapping his client, Khalifa Charif (Sheriff). Kidnapping is a first-degree felony crime in Liberia.

According to Cllr. Ja'neh, Charif's house was raided more than six weeks ago and was later committed to the Monrovia Central Prison by a court order.

However, Cllr. Ja'neh has further claimed that early Sunday morning on November 3, 2024, between 3 and 4 a.m., Col. Coleman headed a team of security

court, which committed Mr. Charif to detention, the security forces took Mr. Charif away.

Counsellor Ja'neh also said that the removal of his client from the Monrovia Central Prison was ordered by senior National Security Actors of the Liberian Government.

"Although my client, Khalifa Charif, spent most of his early childhood in the Republic of Guinea due largely to the Liberian civil conflict, that does not make him a Guinean national, as being falsely circulated by Liberian state Security officials," Ja'neh explained.

According to Cllr. Ja'neh, his client Charif's money was allegedly seized by a joint team of Liberia National Police (LNP) and National Security Agency (NSA) officers who raided his home.

The former Associate Justice alleged that the officers did not present any warrant during the raid.

'To date, the officers who raided Mr. Charif's premises under the instructions of the Inspector General of Police and the Solicitor General, Ministry of Justice, have continued to defy the court's orders to bring to court all of the items seized, including cash and two vehicles," Cllr. Ja'neh said.

This act, according to Cllr. Ja'neh is a concrete demonstration of lawlessness under the Boakai Administration.

Cllr. Ja'neh has vowed to ensure that Mr. Charif is released as ordered by the court without any further delay. The former Justice Minister said that he would personally organize public demonstrations against National Security officers as there is no longer any respect for the court orders under the current administration."The demonstrations against police officers will continue, according to Cllr. Ja'neh, until the court's orders releasing Mr. Charif, are FULLY COMPLIED WITH," a release issued in Monrovia said.

Court rules in favor of Life Saving of Jesus Christ Int'l

A local Circuit Judge has restored squatter rights of Life Saving of Jesus Christ International Church in West Point Township

By: Emmanuel Wise Jipoh onrovia, Liberia, November 12, 2024 - A Circuit Court in Monrovia has ruled in favor of Life Saving of Jesus Christ International, allowing it to reclaim possession of its

damages.

The case involved the church on the one hand and Mr.

or squatter's rights, and prayed to the court to have them ousted from the property.

In its ruling, the Court stated that all testimonies of witnesses and documentary evidence showed that the respondents were wrongfully withholding the Church's property.

The property in question was previously given to an occupant to be used pursuant to Squatter's rights granted by the Township of West Point through Commissioner Charles K. Johnson.

The court documents in the possession of the New Dawn detailed that on May 8, 2023, the (Petitioners) were given the right to reside on the said Property due to the previous occupants having transferred the squatter's rights to Petitioner.

However, it indicates that the squatter's rights given to the Petitioner by the Township of West Point are clearly within the Township's right, and the said rights allowed the petitioner to claim ownership of said property even though said property is not legally
