But Mondlane, the runnerup, rejected the outcome, sparking violent protests that have left dozens dead since October. Mondlane left Mozambique the same month saying he feared for his life, after two of his aides were shot dead.In a They don't need to chase me any more". He said he would arrive at 08:05 local time (06:05 GMT) on Thursday at the international airport in Maputo, calling for people to welcome him there.

"If they are killing my brothers... then I will be there. You can do what you want. If you want to murder, murder. If you want to arrest, arrest too. I will be there," he said.

Mondlane maintains that he won the election and has called for more protests until there is "electoral truth". His supporters have frequently staged violent protests across the country to demand an end previously said he would install himself as president on 15 January - on the presidential inauguration day - despite the court upholding his rival's victory. The electoral commission initially declared Chapo the winner of the election with 71% of the vote, compared to Mondlane's 20%. The final official results from the constitutional court two weeks ago gave Chapo 65% and Mondlane 24%.International election observers have previously said that the vote was flawed, pointing to doctored numbers and other irregularities during the counting process.

Security forces have sought to end the nationwide protests in a violent crackdown that has tested the country's stability. More than 270 people have been killed, including protesters, children and members of the security forces, according to rights groups. The unrest has also affected the economy, with more than 12,000 people losing their jobs and over 500 companies being vandalised. BBC



hree Chinese nationals have been arrested with 12 gold bars and \$800,000 (£650,000) in cash in eastern Democratic Republic of Congo, officials say. The gold and money was hidden under the seats of the vehicle they were travelling in, according to Jean Jacques Purusi, the governor of South Kivu province. He said the operation to arrest the men had been kept secret after the recent release of another group of Chinese nationals accused of running an illegal gold mine in the area. Eastern DR Congo has abundant reserves of gold, diamonds and the minerals used to make batteries for mobile phones and electric vehicles. This mineral wealth has been plundered by foreign groups since the colonial era and is one of the main reasons why the region has been

Purusi said some of these dealers in precious metals enjoyed good relations with influential people in the capital, Kinshasa, and this was why the mission to carry out these latest arrests had to be kept guiet. Kenya has been gripped by a wave of disappearances, with the state-funded rights group saying that over 80 people have been abducted in the last six months. The abductions generally target government critics and are widely believed to be the work of security agents, although the authorities have not admitted responsibility.

They began in June last year during nationwide anti-tax protests, but increased in December, when AI-generated photos of the president in a coffin were widely shared. The youth-led protests forced President William Ruto to withdraw a series of planned tax rises and shook his government, leaving his authority badly undermined.Kibet Bull, known for his silhouette cartoon memes critical of the said his son was not able to discuss what he had gone through adding that he had been taken to hospital. "He came home around eight in the morning. He walked by himself - his

mother and I saw him. We thank everyone who has prayed and supported him," he told the Daily Nation news site. Last week, Mr Mwangi's father

broke down in court as he pleaded for his son to be released.

A relative of 22-year-old Peter Muteti, who was seized in Nairobi, on 21 December, told the BBC on Monday that he had been reunited with the family but was disoriented and unable to speak about the ordeal.Amnesty International Kenya welcomed the releases and urged "the State to free all abductees and hold those responsible accountable". Two weeks ago the police denied responsibility for the abductions carried out by men in plain clothes across the country, some of which were captured on CCTV.

Rights groups and other Kenyans have linked the abductions to a shadowy intelligence and counterterrorism unit of the security forces. Amid the public uproar, president, announced his President Ruto said last month: "We

"I gave him a call and we talked, we didn't talk much, the moment he told me 'I am Kibet' and I heard his voice, I screamed, I celebrated until he hung up," she said. The others released on Monday include 24-year-old student Billy Mwangi in Embu, in the central Mount Kenya region.

On Monday the police released an update acknowledging the freeing of the men, saying they were already in contact with one of the abductees, Bernard Kavuli, who had presented himself at a police station. The police said investigations into all cases of missing people were under way.

One other man - Ronny Kiplangat has also been released, his family told local media.

Mr Kavuli, a content creator, was seized on the outskirts of Nairobi in December, while Mr Kiplangat is the brother of Kibet Bull. Two others were seized after posting Algenerated images of the president. At least 24 people are still missing.BBC

Looking forward to a smooth sailing

iberians look forward with great hope in 2025 for the smooth sailing of the government and the state and for ✓ ultimate political and economic stability. 2024, which ushered in a new government here, saw the Motherland sailing on troubled waters characterized by political tension, uncertainty, fragility, and economic hardship.

Due to missteps, heightened tension, bickering, and near instability, 2024 did not achieve much for this country, with poverty staring at the population. Many parents could not afford to send their children to school while businesses, including commercial banks, were on the verge of closure because of insolvency and seeming recession.

But if we did not get it right last year, 2025 provides a fresh opportunity for the government, citizens, and our business partners to dream again, tighten the bolts, and take off for greater heights, for the upper space is the only option.

This means that the government that took an oath to provide an enabling environment for economic activities and stability must keep to its promise of creating a better country than it met rather than the other way around.

It is a disgrace that during the period in review under the new administration, the University of Liberia failed to reopen largely due to a lack of funds to pay part-time lecturers and to appoint a new president.

Mismanagement of public money took center stage in the first year of the Boakai administration from the 55th Legislature to the Executive, particularly the Ministry of Public Work to the National Port Authority, where millions were spent just on salary, so much so that the NPA could not contribute to the national budget.

The mismanagement of state resources in 2024 under the new administration left many ordinary Liberians wondering whether transparency and accountability no longer exist in public service.

With a new year here, we as Liberians, particularly those entrusted with public offices, should do things differently in the state's interest, for the Motherland is all we have as citizens.

We should all be reminded that no amount of foreign support will fix this nation unless we Liberians sincerely desire better for ourselves and for the next generation.

President Boakai and his government should stand up to the task of nation-building instead of paying lip service. We have heard lots in words, but we need deeds right now!

Will Trump Fire the Fed?

AMBRIDGE - Nearly every cabinet or staff appointment announced by US President-elect Donald Trump has been met with a predictable wave of media outrage. Some of this hysteria can be attributed to deep-seated partisan biases, some reflects legitimate concerns, and some is pure nonsense.

When it comes to the US economy, however, the spotlight is on whom Trump might try to dismiss rather than whom he plans to appoint. Although Trump has said he will not seek to remove Federal Reserve Chair Jerome Powell - whose term ends in May 2026 - there is little doubt that Trump would love to tell Powell, "You're fired."

Trump's antagonism toward Powell is baffling, given that Powell has been doing an excellent job. Though less visually thrilling than a SpaceX booster landing, the Fed's success in achieving a soft economic landing amid aggressive interest-rate hikes is no less spectacular. Such a delicate balancing act has been pulled off only once before, in the 1990s, when monetary "maestro" Alan Greenspan headed the Fed. Given that sharp increases in interest rates typically trigger recessions, economists often consider it a success when the resulting downturn is mild or at least brief.

While no US president has been quicker to fire his appointees than Trump - the former star of The Apprentice - outgoing President Joe Biden moved too far in the opposite direction, refraining from dismissing any member of his cabinet. Most notably, Biden stood by Homeland Security Secretary Alejandro Mayorkas despite Mayorkas's role in overseeing the administration's ill-considered "open borders" policy. And to Trump's credit, the leading candidate to replace Powell, Kevin Warsh, is a highly regarded former Fed governor who has consistently been even more hawkish than Powell.

But regardless of whether he fires Powell, Trump's bid to gain greater influence over the Fed's decision-making risks destabilizing inflation expectations and driving up long-term interest rates. While this process will probably unfold more gradually than some critics suffering from "Trump derangement syndrome" might expect, the consequences could be dire.

In the long term, any attempt by Trump to undermine the Fed's independence could severely impede its ability to respond to economic and financial crises. If inflation expectations are not firmly anchored, policymakers will struggle to stimulate the economy without triggering runaway price growth. Such a presidential "victory" over the Fed would reduce trust in other key institutions as well.

Fortunately, firing Powell is not so simple. While Fed chairs are appointed by the president, their terms are set by statute, which means the president does not have the authority to remove them. Trump could ask Powell to resign, but Powell has already made it clear that he will not step down.

That said, the Fed's independence is not enshrined in the US Constitution. With sufficient support from the Senate and House, Trump could amend the law to dismiss Powell. But for now, the Fed is shielded by the near-certainty that any serious attempt to override its independence would roil financial markets.

If removing Powell is not an option, Trump might name a "shadow" Open Market Committee to undermine Powell's authority and pressure the Fed. Trump has already done something similar with the presidency since being elected in November; the world pays far more attention to him than to Biden.

To be sure, this strategy is unlikely to have a meaningful impact on the Fed. Powell might face pointed questions about the policies of Trump's shadow Fed during congressional hearings or press conferences, but such a group would not carry more weight than other external critics. Unless it consistently outperforms the Fed in forecasting economic trends - a highly improbable scenario - Trump's shadow central bank will simply be ignored.

Still, the risks posed by Trump's approach should not be underestimated. Central-bank independence is arguably the most important macroeconomic-policy innovation since the supply-side revolution of the 1970s. While inflation targeting and the "Taylor rule" have played a pivotal role in shaping modern monetary policy, they rely on central banks' credibility and autonomy. Historically, central banks led by technocrats focused on maintaining price stability have consistently outperformed those plagued by political interference.

To understand the stakes, suppose Trump manages to fire Powell and pressures the Fed to keep interest rates low to boost economic growth, particularly during his first two years, before Democrats likely retake the House of Representatives. Longer-term interest rates - such as those on home and car loans, which the Fed does not control directly - would almost certainly rise, first gradually and then dramatically. Before long, the Fed would be forced to reverse course, eroding its credibility and weakening the US economy.

The good news is that for all his capriciousness, Trump is ultimately a pragmatist, not an ideologue. The long-term consequences of undermining the Fed's independence would be in no one's interest, including his own.

The Economic Consequences of Trump 2.0

ASHINGTON, DC - US President-elect Donald Trump's second administration starts at noon on January 20. Trump's non-stop election campaign since losing to Joe Biden in 2020 suggests a better organized redo of his first term, with the same focus on tax cuts to boost the economy, higher tariffs to reshape US trade with the world, and deporting as many immigrants as possible to generate more opportunities for American workers. But times have changed, and reality is unlikely to match rhetoric.

In 2016, when Trump first won the presidency, the United States was experiencing a prolonged period of low inflation. The Federal Reserve kept interest rates near zero throughout his administration. This time, however, is quite different. Inflation spiked during the COVID pandemic, and the Fed is still on guard against a resurgence - hence interest rates remain relatively high. Trump's proposed tax cuts imply a fiscal stimulus for an economy with low unemployment. Any signs of overheating will be met by tighter monetary policy.

Trump has made noises about changing the leadership of the Fed, but he cannot fire Fed Chair Jerome Powell without risking both higher long-term interest rates and higher inflation. There will be tax cuts in 2025, mostly for rich people, and the consequent loss of revenue will undermine long-term fiscal sustainability. Larger deficits will keep interest rates higher than they would be otherwise, and the dollar may strengthen, creating difficulties for US exporters and for countries that have borrowed in dollars.

On tariffs, the world's leaders (and financial markets) have come to understand that Trump talks loudly and carries a pretty small stick. He will no doubt noisily impose some high-profile tariffs, but US business interests will immediately begin seeking loopholes and lobbying for exceptions. Foreign leaders will make the pilgrimage to Mar-a-Lago, play some golf, and negotiate mutual carve-outs (we won't tax your bourbon, if you don't tax our cognac, and we'll buy more US-made air defense systems).

Trump could ignore all this special pleading and insist on higher tariffs across the board. But that will bring more retaliation from trading partners and more protests from the big companies that now back him. The last thing Trump wants is to cause domestic job losses, which could happen if US-based companies must pay more for imports and lose competitiveness in export markets. If foreign leaders don't make him look bad on the golf course and emphasize the jobs their companies create in the US (particularly in Republican-controlled states), everything will be up for reasonable discussion.

On illegal immigration, Trump is sure to have impact. The "border wall" is an illusion with no real meaning. But Trump is already threatening to punish Mexico and other countries (even Canada!) with high tariffs and other measures unless they hold back immigrants, and this will have some effect. Trump may also be clever enough to relax US sanctions on Venezuela, allowing more oil onto the world market and also helping the Venezuelan economy. That would reduce pressure on Venezuelans to emigrate, while also squeezing Iran and Russia (both of which rely on oil sales to finance purchases of electronic parts from China for use in weapons).

Trump could go further by rounding up and deporting millions of people who are in the US illegally. But mass deportation would harm major sectors of the economy (such as agriculture and construction), fuel massive social disruption, and cause his business allies to cut back on their investments (and job creation). Again, we should expect to see political grandstanding and sensational headlines, but the reality will not be much changed (illegal immigration has already fallen).

So, what will Trump really do? Will he purchase Greenland (or Canada!) or somehow reacquire control over the Panama Canal or reduce US support for NATO? None of Trump's recent statements on these topics are meaningless, but nor should they be taken literally. Again, Trump wants to get what he considers (and what he can portray as) a "better" deal for the US. If he doesn't say what that means now, it just means he is open to suggestion - or he can just define whatever the end point turns out to be as a strategic victory.

That's what happened during Trump's first administration, when NAFTA (the North American Free Trade Agreement) was renegotiated with Mexico and Canada. Trump had originally threatened to tear up NAFTA "on day one." Eventually, he settled for small modifications (including amending the rules of origin in a way that was acceptable to all sides) and a rebranding that turned NAFTA into the USMCA (the United States-Mexico-Canada Agreement).

A broader reshaping of the world is afoot, but this has nothing to do with the incoming administration, which is unlikely to respond effectively. For example, Trump is still using bellicose language about confronting China and Iran, but both are already in bad economic shape and hardly pose a threat to regional order - let alone international peace. And, as he did in his first administration, Trump promises to withdraw from foreign interventions (Afghanistan and Iraq then; Ukraine now). But Russia's need for drones and missiles to launch at Ukraine has made President Vladimir Putin fully subservient to China. Does Trump (and the Republican Congress) really want to hand a weakened President Xi Jinping an illegitimate and bloody victory in Ukraine?

What American voters really care about is good jobs and the cost of living. But Trump's "populist" agenda - a smoke-and-mirrors program, sustained by fear of imagined enemies - is a failure foretold. Trump inherits a strong economy, but his signature policies will do almost nothing positive for less educated workers or significantly improve the lives of most other Americans. Instead, the rich will get richer, the richest will get a lot richer, and everyone else will most likely struggle with higher inflation, cuts to public services, and the effects of runaway deregulation.

The suspended lawmakers are Rep. Frank Saah Foko of Montserrado County Electoral District #9, Rep. Eugene Kollie, Rep. Zinnah Norman, and Rep. Alex Sonnyboy Noah.Others are Rep. Marvin Cole, Rep. Abu Kamara, and Rep. Edward Papay Flomo. While their session was ongoing, suspended lawmaker Eugene Kollie entered the session.But Presiding Officer Richard Koon told Rep. Police, National Bar lament decline in rule of law

The Liberian National Bar Association and the Liberia National Police are attributing wave of mob violence-related deaths across the country to decline in the rule of law and lack of public trust in the judicial system.

onrovia, Liberia, January 7, 2025 Liberia National Police and the Liberian National Bar Association express serious frustration about law enforcement and the Justice sector of the country in the wake of rising mob violence and lack of public trust and legitimacy in the judicial system.

However, the Inspector General of Police Gregory Coleman, attribute the situation to lack of trust and legitimacy in law enforcement and the justice system here.

Addressing a press conference over the weekend when he provided update on several crimes committed across the country, IG Coleman explained that there are multiple reasons why mob violence is on the increase in Liberia. According to him, one of the major challenges is low trust in the but they don't control what happens beyond that point. "I think it's one of the things we should fight for not just in the law enforcement sector but the entire local justice sector is public trust and legitimacy."

At the same time the National Bar Association through its Secretary General, Cllr. Bornor M. Varmah, condemns all acts of mob violence recently carried out by some citizens against some alleged criminals, lamenting that the upward trend in mob violence undermines the rule of

According to him, the increase is particularly disturbing, as these activities are seemingly more violent, with a tendency to kill victims and turn against security forces, who attempt to intervene.

Cllr. Varmah reminds all Liberians that since the end of Liberia's civil war, mob violence has become a frequent occurrence for alleged criminals to be literally lynched, sometimes to death, by an angry mob, including bystanders, who simply have no inkling about the

La chute de la maison Assad

EL AVIV - L'effondrement rapide d'une dynastie al-Assad vieille de 54 ans en Syrie vient transformer le paysage géopolitique du Moyen-Orient. L'offensive éclair de la milice islamiste Hayat Tahrir al-Sham (HTS) a surpris tous les voisins de la Syrie, comme le reste du monde. L'annonce de la fuite du président Bachar al-Assad en Russie confirme une vérité incontournable s'agissant des guerres : des conséquences inattendues peuvent s'étendre bien au-delà du champ de bataille.

L'attaque du 7 octobre 2023 perpétrée par le Hamas contre des communautés civiles israéliennes à proximité de la frontière de Gaza a provoqué plusieurs séismes dans l'ensemble du Moyen-Orient. L'impitoyable offensive menée par Israël pour détruire le Hamas à Gaza et le Hezbollah au Liban a quasiment anéanti « l'axe de résistance » iranien, tandis que les États-Unis et le Royaume-Uni ont bombardé les Houthis soutenus par l'Iran au Yémen, en réponse à leurs attaques contre des navires commerciaux internationaux.

La guerre civile syrienne a débuté en 2011, lorsque le régime d'Assad a écrasé les manifestations pacifiques du « Printemps arabe ». Puis les combats se sont largement atténués après 2015, l'intervention de la Russie, avec l'aide de l'Iran et du Hezbollah. ayant inversé le cours de la guerre en faveur d'Assad. Dernièrement, les proxies de l'Iran ayant été détruits, et les capacités de combat de la Russie étant éprouvées par la difficulté du conflit en Ukraine, les rebelles ont saisi l'opportunité.

Avec l'<u>appui</u> de la Turquie, et semble-t-il du Qatar, les rebelles ont facilement pris d'assaut les défenses étonnamment fragiles du régime syrien, et l'armée d'Assad a capitulé sans combattre. L'Iran et la Russie, protecteurs d'Assad, ayant précipitamment évacué <u>leurs troupes</u> et abandonné le dictateur à son sort, le régime syrien fondé sur la torture et les massacres n'inspirait plus la peur.

La fin de l'alliance de l'Iran avec la Syrie, principal bastion du régime de Téhéran dans le monde arabe, est vouée à redéfinir l'équilibre régional des puissances. Comme l'exprimait l'ancien vice-président iranien Mohammad Ali Abtahi deux jours avant la fuite d'Assad, un effondrement du gouvernement syrien « constituerait l'un des événements les plus importants dans l'histoire du Moyen-Orient... La résistance dans la région se retrouverait privée de soutien. Israël deviendrait la puissance dominante ».

« Hayat Tahrir al-Sham » signifie la libération du Levant, qui dans le lexique politique du premier califat inclut la Syrie, le Liban, la Jordanie et la Palestine. Le chef du groupe islamiste HTS, Abou Mohammad al-Joulani, tente néanmoins de projeter l'image d'un islamiste d'un nouveau genre. Il semble avoir tiré les enseignements nécessaires des échecs d'al-Qaïda et de l'État islamique (EI), et se considère désormais comme un pragmatique aspirant uniquement à « libérer la Syrie de son régime tyrannique ».

Signe de ce nouveau pragmatisme, Joulani a <u>ordonné</u> à ses hommes de laisser le Premier ministre syrien Mohammad Ghazi al-Jalali continuer de gérer les institutions publiques jusqu'au transfert officiel du pouvoir. Par opposition, l'El aurait certainement procédé à des exécutions massives de soldats et responsables publics.

Joulani n'en demeure pas moins à la tête d'une organisation islamiste radicale. Ceux qui <u>'sattendent</u> à ce que la Turquie tempère l'extrémisme du HTS présument que Joulani sera le soldat obéissant d'Ankara. Ce qui est sûr, c'est que Joulani va devoir composer avec de puissantes contraintes politiques, notamment avec les nombreuses milices rivales qui se sont unies pour faire tomber Assad, ainsi qu'avec les forces kurdes qui se sont empressées de prendre le contrôle de nouveaux territoires dans l'est de la Syrie, tout en subissant les <u>attaques</u> des forces turques au nord.

Aux yeux du président turc Recep Tayyip Erdogan, les ambitions des Kurdes de Syrie menacent d'alimenter une rébellion nationaliste au sein des communautés kurdes de Turquie. En 2019, Erdogan a ordonné à son armée de mettre en place une « zone de sécurité » de 30 kilomètres de large dans le nord de la Syrie, et de repousser les combattants kurdes loin de la frontière turque, zone dans laquelle les Kurdes avaient saisi l'opportunité de la guerre civile pour consolider une enclave autonome.

omté de Margibi, Libéria — La Salala Rubber Corporation (SRC),

l'un des principaux producteurs de caoutchouc du Libéria, a été 'confrontée à de vives protestations de ses travailleurs au mois de juillet dernier, principalement en raison de conditions de vie insatisfaisantes sur ses plantations. Ces protestations ont mis en lumière des problèmes persistants, notamment des logements vétustes, des soins médicaux insuffisants, des salaires faibles et des pratiques de gestion douteuses. Les manifestations ont conduit à des destructions importantes, notamment l'incendie du bâtiment administratif.

SRC, fondée en 2007 à la suite d'une fusion, était précédemment détenue par la multinationale belge Socfin. Jusqu'à cette récente crise, la société était critiquée pour ses conditions de travail difficiles. Les logements de ses employés étaient jugés insalubres et anciens, certains datant des années 1950, et la gestion des soins de santé laissait à désirer, avec un accès limité aux services médicaux.

Un changement radical de direction

L'année dernière, l'entreprise a été rachetée par l'homme d'affaires indien, le Dr Upjit Sinch Sachdeva, également connu sous le nom de M. Jeety. Bien que le montant de la transaction soit resté confidentiel, ce changement de propriétaire a marqué une nouvelle ère pour SRC et ses employés. Une récente visite d'investigation de *The New Dawn*, le 3 janvier 2025, a permis de constater les améliorations notables sous cette nouvelle gestion.

Sous la direction de M. Jeety, plusieurs des problèmes qui avaient été signalés précédemment ont commencé à être résolus. Des améliorations significatives ont été apportées en matière de logement, de soins médicaux et de rémunération, apportant un nouvel espoir aux travailleurs.

Des améliorations dans les soins de santé

L'une des premières mesures prises par M. Jeety a été la rénovation du Centre de santé SRC-Jeety Conglomerate. Le Dr Ahson Malik, médecin généraliste



à la clinique, a expliqué que l'établissement était resté fermé pendant plusieurs mois avant son intervention. "Il a réhabilité la clinique, recruté du personnel et élargi les services. Aujourd'hui, la clinique fonctionne 24 heures sur 24 et 7 jours sur 7, offrant des soins d'urgence, des consultations externes et des services de maternité", a précisé le Dr Malik.

Les soins médicaux pour les travailleurs et leurs familles sont désormais gratuits, avec des tarifs réduits pour certains services, comme les accouchements. Les frais, qui étaient autrefois compris entre 3 000 et 5 000 dollars libériens, sont désormais fixés à seulement 1 000 dollars libériens. La clinique offre également des traitements gratuits pour des maladies telles que le VIH, la syphilis et le paludisme.

Le Dr Malik a noté que le nombre de patients a augmenté de manière significative depuis la rénovation de l'établissement. "Nous recevons entre 20 et 25 patients par jour et assurons des urgences nocturnes, y compris des accouchements", a-t-il ajouté. "Nous avons également lancé des programmes de prévention du paludisme et de la tuberculose, ce qui montre que la communauté commence à avoir confiance en nos services."

Amélioration des conditions de travail et des salaires

Les travailleurs ont salué les améliorations apportées aux conditions de travail et à la rémunération. Joseph Sackie, responsable du Camp Deux, a expliqué que sous l'ancienne direction, les travailleurs se sentaient souvent délaissés. "Les conditions étaient vraiment mauvaises, mais depuis l'arrivée de M. Jeety, nous avons vu des améliorations notables", a-t-il déclaré.

Fatu Fallah, une nettoyeuse de tasses, a évoqué une augmentation de son salaire sous la nouvelle direction. "Avant, je gagnais seulement 15 USD par mois, maintenant je touche 85 USD, plus un sac de riz de 25 kg", a-t-elle précisé. Elle a également noté que la situation financière des travailleurs s'était améliorée avec des primes de Noël et la possibilité de demander des avances sur salaire.

D'autres travailleurs, tels que Abenego S. Cooper, superviseur au Camp Un, ont évoqué les efforts déployés pour améliorer les logements et la sécurité de l'emploi. "Il y a encore des défis, mais l'initiative de M. Jeety est claire : il veut améliorer la vie de ses employés", a ajouté M. Cooper.

The bad blood is brewing from a legislation making ports under the NPA autonomous much to the dislike of Director Dukuly, who expresses frustrations against Pro-Temp Kangar Lawrence over the passage of a bill that seeks to establish a Sea Port Authority that will grant autonomy to smaller ports across the country and in effect, scratch the power of the National Port Authority that he presently heads.

The Liberian Senate on Tuesday, November 19, 2024 controversially passed into law a bill seeking to create the Liberia Sea Port Regulatory Authority and the Liberia Sea Port Decentralization, thereby granting ports across the country autonomy.

The bill, when concurred by the House of Representatives, will provide for the regulation and sustainable development of Seaports and Inland Ports' operations and services in Liberia. It will also facilitate a safer, orderly, and transparent development of port facilities and services and other

The Senate made the decision following a recommendation by the Joint Committee on Government, which includes but is not limited to, decentralization of the Management and operation of the four seaports that had been managed by the National Port Authority, including the Freeport of Monrovia, the Port of Buchanan, Port of Greenville, and the Port of Harper, respectively.

However, speaking in an interview with The NEWDAWN over the weekend in his Office on Bushrod Island, Director Dukuly said arguments provided by the Senate for the enactment of the bill are marked with flaws and are incorrect, purely meant to support selfish desire of few people.

He names nobody but according to him, it's too early for the Senate to remove the rug from under his administration, being fully cognizant that ports in Liberia lack facilities and best practices to become selfsustainable. He notes that after the decision was made by the Senate, he spoke with some senators, expressing his disagreement privately, why ports should not be granted autonomy.

Majority bloc in search of SONA venue

The House leadership says the Legislature is in talks to identify a more suitable venue for the President to deliver the State of the Nation Address because of ongoing renovation work at the Capitol.

The majority bloc of the ■ House of Representatives says the 2024 State of the Nation Address (SONA) will not be held in the William R. Tolbert Joint Chambers at the Legislature.

The bloc's Chairman on Rules, Order, and Administration at the House of Representatives, Rep. James Kolleh, says the decision is due to ongoing renovation work at the Capitol Building.

Briefing journalists, Kolleh argued that it is impractical to complete the renovation work before January 30, 2025, the constitutionally mandated date for the President to deliver the SONA.

"It is not possible for us to do renovation work from now to return on January 13, 2025. So, the issue of talk of having SONA at the Capitol is hereby cancelled," Kolleh disclosed.

In December 2024, the Joint Chamber of the Capitol Building was destroyed by fire at the height of a political crisis that rocked the Legislature.

The joint chamber was the meeting point of the majority bloc of the House of Representatives which dethroned House Speaker Jonathan Fonati Koffa and elected Richard

In presenting the economic condition of the Republic, the Constitution mandates that the report shall cover expenditure as well as income.

This year's address is expected to shed light on key initiatives under President Joseph Nyuma Boakai's


Chief Allen urges Boakai to demonstrate leadership

Chief Allen urges Boakai to demonstrate leadership

President Boakai is under immense pressure to put Liberia on the right trajectory for economic development and growth.

onrovia, Liberia, January 7, 2025 - A member of the Advisory Council of the Coalition for Democratic Change (CDC), Chief Cyril Allen, urges President Joseph Nyuma Boakai to harness

President Boakai's wealth of experience in public service when she appeared on Spoon Talk on Sunday, January 5, 2025, Chief Allen argued that Mr. Boakai's decades of involvement in governance, spanning over 40 years, should be leveraged for the

resources, a fact that should not be overlooked, and urges the President to demonstrate firm leadership to ensure the country's resources are used effectively.

look back at past initiatives, such as the Lofa County Agriculture Development Project and the Bong County Agriculture Development Project, which he notes, once provided thousands of jobs and contributed significantly to the country's agricultural output.He also references Liberia's potential in the fishing industry, citing the country's 300 miles of coastal waters and the opportunity to invest in modern fishing boats and processing vessels.
